

19) *Provide all drafts of the Letter of Intent and the Affiliation Agreement entered into with Adventist Health and all communications related thereto.*

Attached at Tab 19-1 are 5 drafts of the LOI, consisting of the initial draft (version .1) prepared June 1, 2018, and three “redline” drafts (versions .2, .3 and .4) prepared June 6, 2018, June 14, 2018, and July 24, 2018, each reflecting the changes made from the prior draft. All of these drafts were prepared “internally” and reflect comments received from William Noble, Bahram Ghaffari, Wes Bilson and Kaufman Hall and Associates representatives. Version .4 was sent to Adventist Health on July 24, 2018. Based on comments received from Adventist Health, version .6 was prepared (version .5 was merely an internal processing glitch and was not circulated to anyone). Version .6 was signed by the parties on August 21, 2018.
